

Fire Evacuation Procedure

Whilst at the College, visitors are subject to the Health and Safety at Work Act 1974. If the **fire bell sounds**, visitors please follow your host to the nearest exit. Contractors please leave by your nearest exit. You will be guided to walk to the muster point.

All visitors and contractors should then report to reception staff who stand behind the students.

Visitors and contractors must abide by the College Safeguarding/Child Protection guidance.

No smoking / vaping is permitted on the premises at any time.

Our Commitment

We ensure all our staff share our commitment and are dedicated to the protection of all the students entrusted to our care. We have a team of Designated Senior People (DSP) who are responsible for maintaining positive relationships across the College and offering support to our students at all times.

Everyone working with our students should be aware that:

- Their role is to listen and note carefully any observations which could indicate abuse
- They should not attempt to investigate once initial concern is raised
- They should involve Designated Senior People (DSP) immediately
- If the DSP's are not available the Headteacher should be contacted
- A disclosure of abuse or harm can be made at any time (lesson times, break times, after school etc.)
- Before outside agencies are invited to the College to work with our students or to carry out work on the College premises, staff are required to ensure that all relevant DBS checks and identification has been seen.
